Wills and Trusts

One of the most common ways to plan a gift is by bequeathing it in your will or living trust. The following is sample text that might be helpful for your tax advisor or attorney when planning your bequest:

To designate Save Mount Diablo as your beneficiary, simply

- Contact the institution holding your assets and request a beneficiary form (also referred to as a designation form). This can typically be found on the institution's website.

- Return the completed form to your plan administrator, insurance company, or financial institution.
